TESA BYLAW CHANGE PROPOSAL

PURPOSE

To clarify that a Past State President will conduct the annual Installation of Officers at the State Convention, and that any Past State President, or the current President may install Officers appointed or elected to fulfill unexpired terms because of vacancies after the Installation.

CURRENT

Section 3.020.2: The installation of the President, President Elect, all Vice- Presidents, Secretary elected to a new term, Treasurer elected to a new term, new Trustees, and appointed Officers will be installed during the second business session (Saturday) of each Annual State Convention of TESA. Reference Table 1 immediately following these By-Laws, for the expiration date of TESA Trustee terms.

PROPOSED

Section 3.020.2: The installation of the President, President Elect, all Vice- Presidents, Secretary elected to a new term, Treasurer elected to a new term, new Trustees, and appointed Officers will be **conducted** during the second business session (Saturday) of each Annual State Convention of TESA. Reference Table 1 immediately following these By-Laws, for the expiration date of TESA Trustee terms.

A Past State President, selected by the incoming President, will conduct the Installation Ceremony.

Any Past State President or the current President, may conduct the installation of any duly elected or appointed officers should a vacancy occur after the annual Installation of Officers. Such ceremony may be conducted at any Lodge, District or State meeting or function.
